# eID Tax Use Case - Program Spotlight



## **Problem:** *Fraudsters are stealing tax refunds (>\$20B per year)*

- No true way for the taxpayer to prove their identity online
- Fraudsters file fake tax returns in advance of the actual taxpayer
- Federal & state governments pay within 30 days but take months to match financial data
- Governments lose money to fraudsters yet still have to pay taxpayers after the identity theft is remedied
- Agency's fraud detection tools are outdated or insufficient

## **Our Solution:** *Authenticate taxpayers against their trusted MVA Record*

- Taxpayers download the eID app, scan their DL/ID and take a selfie to register for their MorphoTrust® eID
- MorphoTrust uses the DL/ID and selfie to authenticate against the MVA (in this case ALEA)
- Upon registration, taxpayers visit their DOR's website to opt-in and lock their account with their eID by using the app to scan a QR code that appears on the DOR's website
- Once a tax refund is filed, the DOR sends a notification to the taxpayer's eID app on their phone, asking them to approve or deny the claim filed.

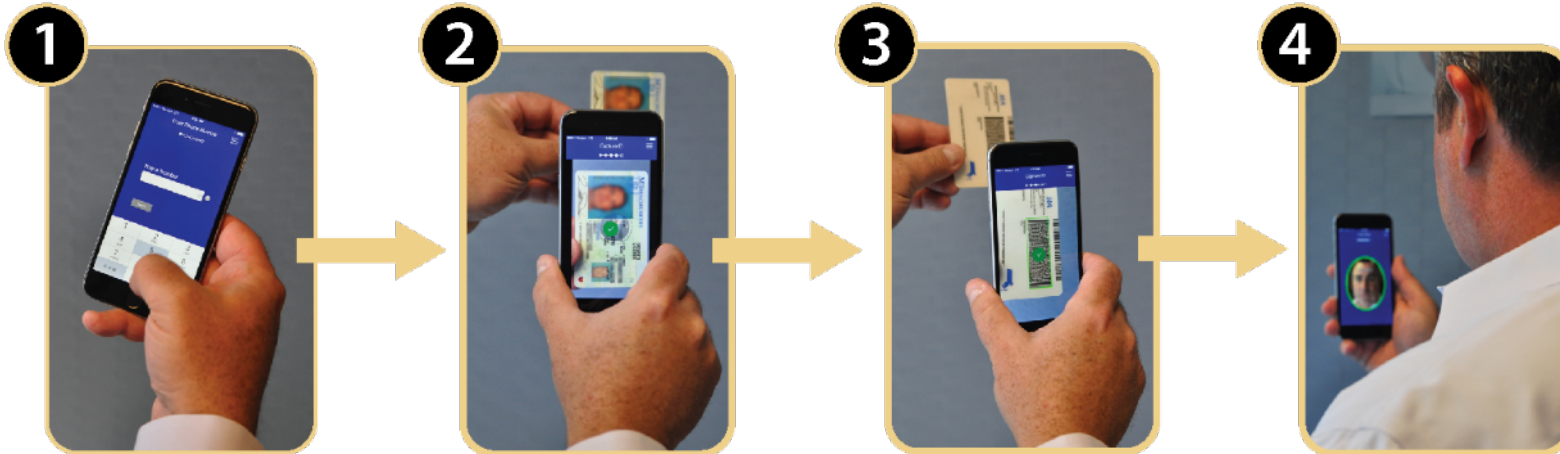

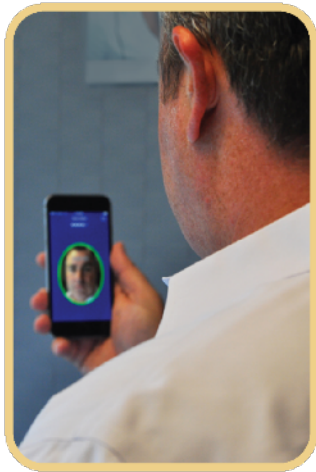

# General Process for Using an eID



1 Open with selfie



**Biometric Unlock** ensures the person holding the phone is the same that registered for the eID

2 Go to relying party login screen on computer



3 Click on eID button

4 Scan QR code to gain access on mobile phone

# eID Notification for the Taxpayer

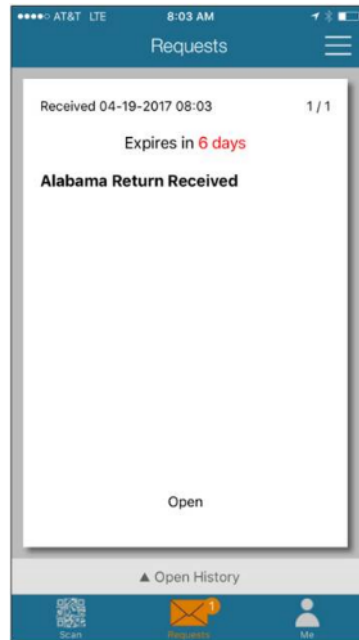


## Step #1



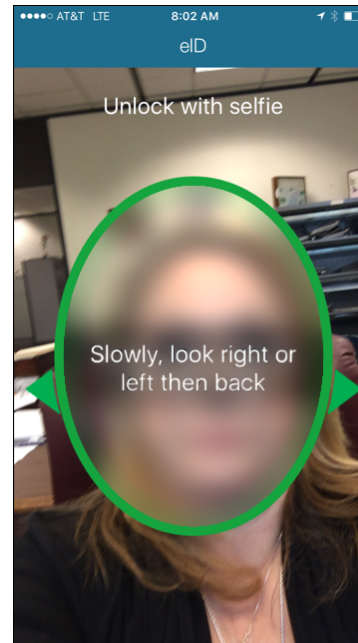
Notification alert appears on taxpayer's phone

## Step #2



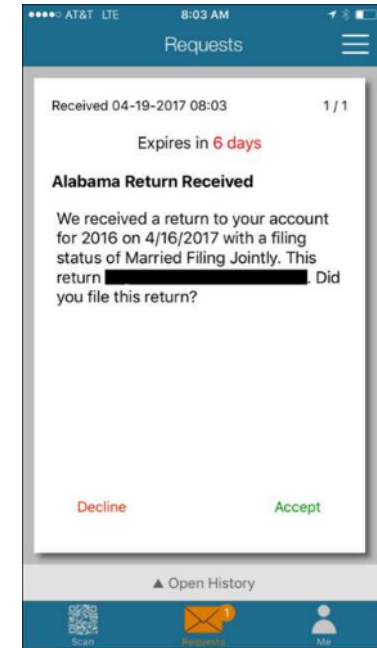
When the notification is clicked, the eID app launches

## Step #3



Taxpayer takes selfie to open full notification alert

## Step #4



Notification alert shows details including date of file, filing status and other information, and asks filer to "Accept" or "Decline"

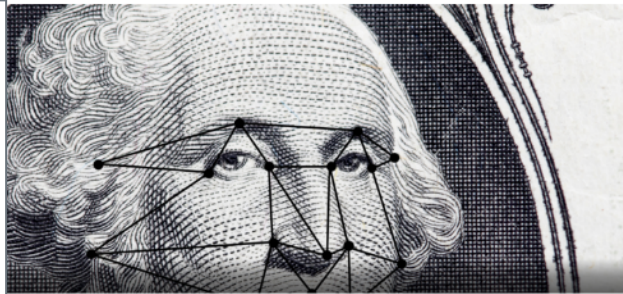

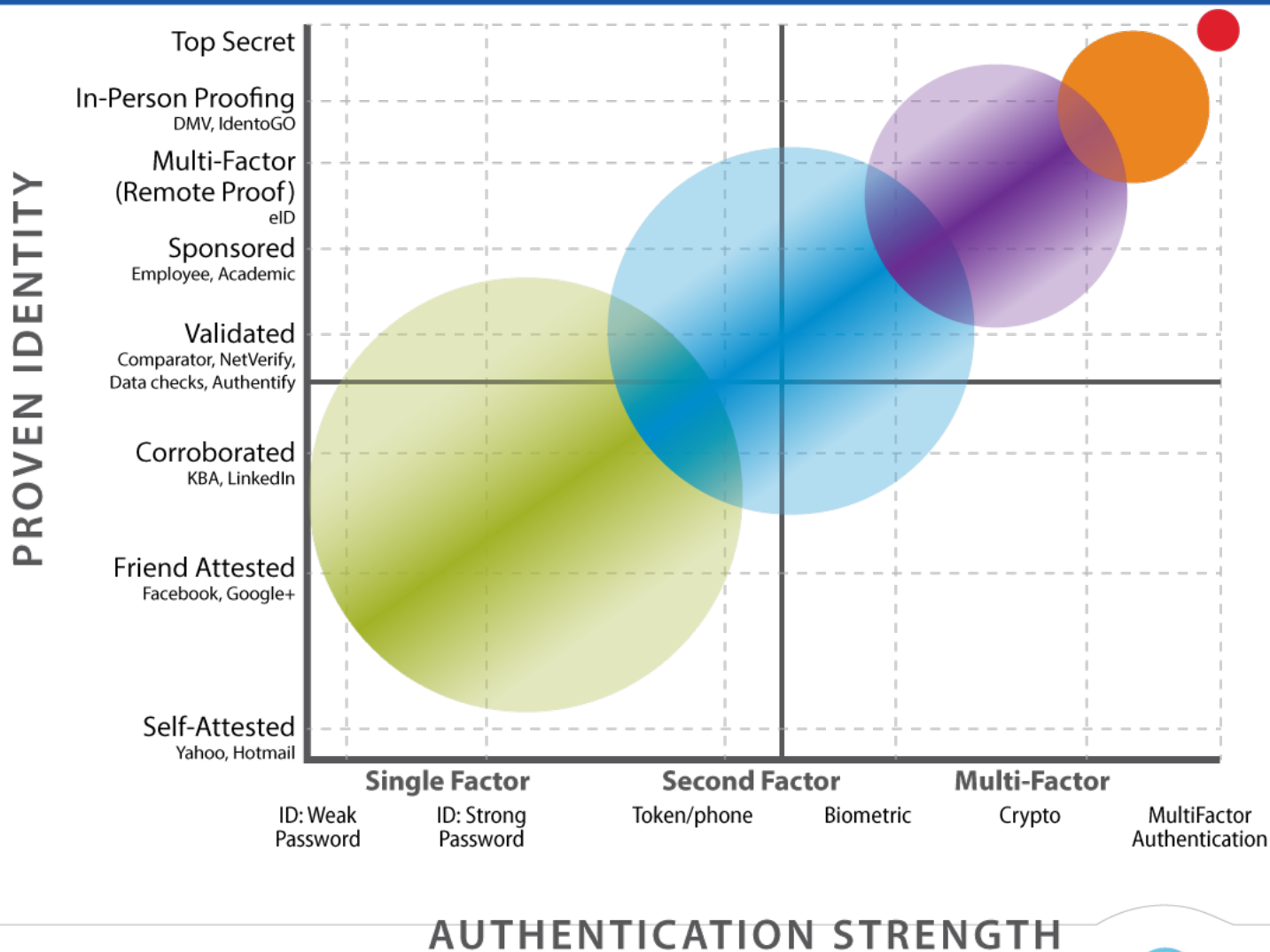

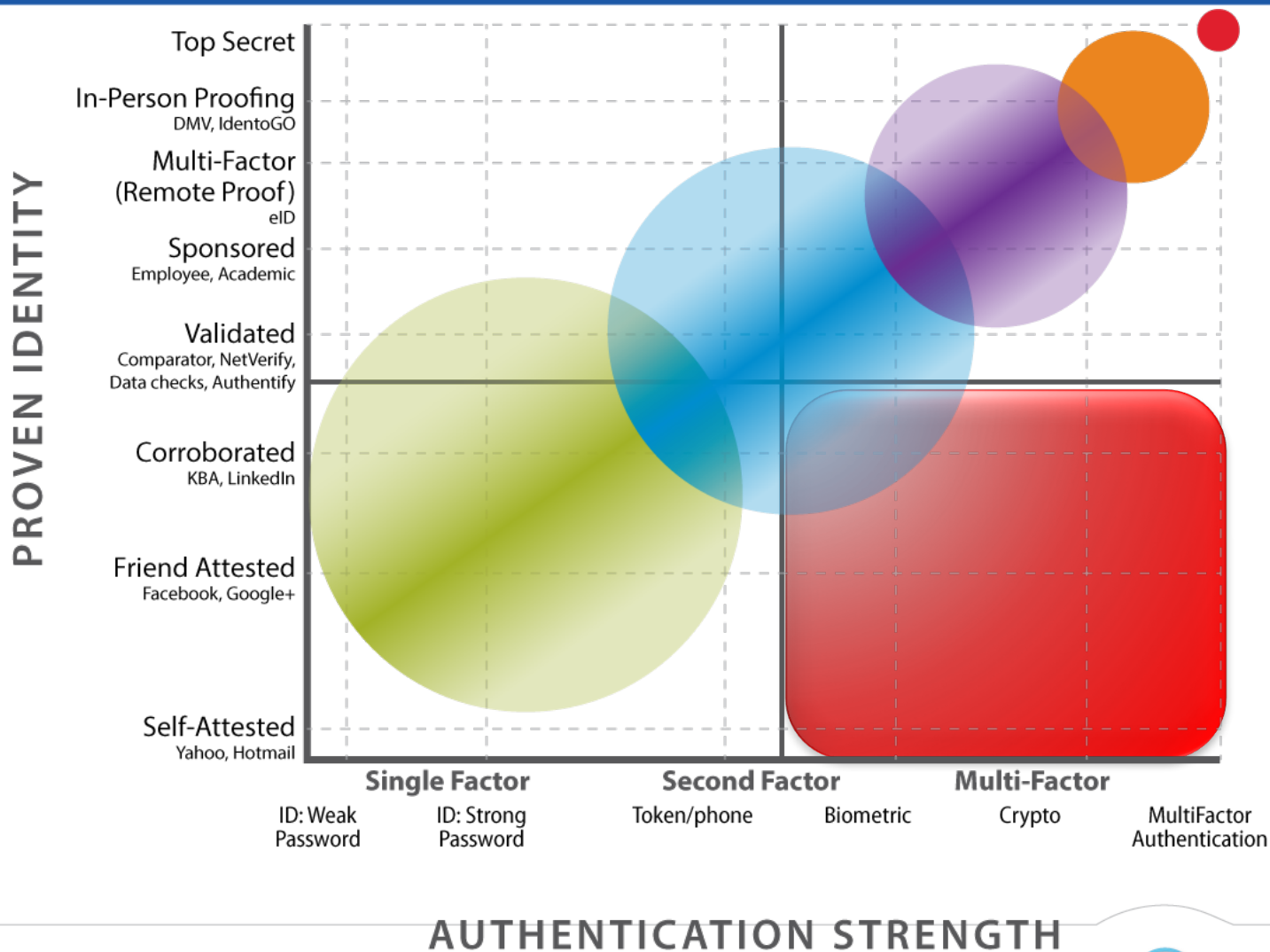
