# Prior to Registry:

- File and release ~39,000 liens annually
- File and release liens in 102 Illinois counties
- Upfront yearly costs for filing and releases - \$600,000
- Yearly man hour costs for filing and releases - \$100,000

# Statute Citation

- 35 ILCS 750 State Tax Lien Registration Act (1/1/2018)

# What didn't change?

- Taxpayers continue to be afforded all of their rights to appeal a debt before it is lienied
- Liens continue to be filed toward the end of the statute period
- Liens are identified by county

# How does the State benefit?

- Estimate an additional \$7 million each year in recoveries
- Elimination of \$600,000 in annual filing and release fees
- Elimination of \$100,000 in annual man hour costs related to liens

# How do taxpayers benefit?

- No fees for lien filings or releases
- Improve timeliness of lien releases

# How do researchers benefit?

- All liens are recorded in one system instead of having to research individual counties
- Registry is accessible and searchable from any location and on any device with internet access
- Filings and releases are immediate
- Ability to use multiple search criteria – including by county

# Searching Options

- Lien Identification Number
- Taxpayer Federal Employer Identification Number
- Taxpayer Name
- Taxpayer Address (Street, City, State, and/or Zip)
- Last 4 of Social Security Number with Last Name
- County of Lien Filing
- Date(s) Filed or Released
